

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an obedience or rally trial held under these regulations is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. (20.7)

No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action. (4.1.5)

#### **ENTRY INFORMATION**

**1**. Attention U.S. Exhibitors: A Personal cheque will be accepted, however, it must be payable in US funds and for the full entry amount. Personally discounted cheques will not be accepted. Do not mark cheque "payable in Canadian" or "funds at par". Your co-operation is appreciated.

2. If entering the same dog in Obedience, Rally or exhibition only please use a separate entry form for each class.

**3**. An **INCOMPLETE ENTRY FORM WILL BE RETURNED**. Please ensure that your postal code is included. ALL NSF CHEQUES WILL BE CHARGED A \$30.00 SERVICE CHARGE.

# 4. EXHIBITORS MUST ABIDE BY THE ERRORS MADE WHEN MAKING THE ENTRY, REGARDLESS HOW OR WHO MADE THE ENTRY.

# 5. TO COMPLY WITH CKC REGULATIONS, WE WILL BE UNABLE TO ACCEPT OR SUBSTITUTE ANY ENTRY REACHING THE SHOW/TRIAL SECRETARY AFTER THE CLOSING DATE AND TIME.

**6**. An entry will not be accepted unless accompanied by the required fees. Post-dated cheques will not be accepted.

7. The Cobequid Dog Club reserves the right to reject any entry subject to CKC rules.

8. Only dogs, which are eligible for registration or are registered by the CKC, may be entered in these Show & Trials.

9. Overpayment of entry fees up to a maximum of \$5.00 will be considered a donation to CDC Trophy Fund.

**10**. The Exhibitor is responsible for knowing and complying with the Dog Show Rules of the CKC.

**11**. There will be no prong or spike collars permitted at this venue.

**12**. Obedience Trial – Move Up. A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules, may be moved to the next level of Obedience competition providing the transfer was submitted to the Trial secretary, **IN WRITING** by the owner or handler, one hour prior to the opening of the first trial, trial schedule permitting.

**13.** The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

#### Temporary Competition Number (TCN) - Effective January 1, 2023

Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). Listed Breeds that do not yet have a Miscellaneous Class Number (MCN) number will be eligible to apply for a TCN.

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account. A dog may not move to the Specials class with a TCN. The dog must be fully registered with the CKC – CKC registration, ERN or MCN.

#### **GENERAL INFORMATION**

THE PRECINCTS OF THE TRIAL WILL BE THE SHOW BUILDING AND ENTRANCE. The show premises will be **opening at 7:30 am each day. The Trial Judging** will **start at 9:00am** unless entries warrant an earlier start. Judging schedule and identification will be mailed/emailed as soon as possible after the entry closing date. The Cobequid Dog Club will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of an accident or other misfortune to dogs, exhibitors or patrons. Judging will not be delayed to accommodate an exhibitor or handler who fails to have his/her dog in the ring when required. The Show Superintendent will be in full charge of the trials. Exercise pens will be restricted at the discretion of the Show Superintendent. Only dogs entered in the show are permitted within the show precincts please. If because of; an act of God, riot, civil disturbance, extreme weather event, governmental orders, regulations, or decree, or other acts or circumstances beyond the control of the CDC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.

### **OFFICIAL JUNIOR HANDLING**

There will be Junior Handling **OBEDIENCE** Saturday. Registration will be at the Show Secretary's table in the morning, and must be done at **least one hour** in advance of the scheduled judging. Dogs competing in Junior Handling must be entered in one of the regular classes or in Exhibition Only. **A fee of \$2.00 for Junior Handling is required at time of registration. Advanced notice of Obedience entry would be appreciated.**

EXHIBITORS ARE EXPECTED TO KNOW THE RULES AND REGULATIONS FOR DOG SHOWS, OBEDIENCE AND RALLY TRIALS. BOOKLETS ON DOG SHOW, OBEDIENCE AND RALLY TRIAL RULES ARE AVAILABLE FROM THE C.K.C. or on the C.K.C. website Exhibitors entering both Obedience and Rally must fill out separate entry forms.

#### **Event Registration Number (ERN)**

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN) from the Canadian Kennel Club. **Effective January 1, 2023**, the policy has been changed to allow Listed Breeds registered with a different Canadian registry to also apply for an ERN. Canadian Born dogs that are registrable by a breed association in Canada recognized by Agriculture Canada may obtain an ERN. To obtain an ERN simply do the following:

- 1. Send a photocopy of the dog's registration certificate reflecting current ownership to CKC, for example AKC Registration Certificate with a written request for an ERN.
- 2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
- 3. Ensure that you provide your full return address to enable to enable the ERN to be sent to you.
- 4. Faxed requests will be accepted. Please indicated your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores. Please forward your request to:

# ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANA-DIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles.
