- 2. Dogs must be kept under control at all times, and must be kept on leash or crated, at all times except when competing.
- 3. The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any trial held under CKC rules.
- 4. Exhibitors will be responsible for picking up after their dogs.
- 5. There is limited shade. Exhibitors are advised to bring their own shade, crates, etc.
