GERARDO BERNARD graduated with a degree in marketing and business administration, has been involved in the dog world since he was 12 years old. His interest in dog shows began with his aunt, with Labrador Retrievers and German Shorthaired Pointers. He competed as a Junior Handler right from the time he first started in the dog world and between 1999 and 2003 he was in the Top 4 Junior Handlers in Mexico. As a Junior, he handled Labrador Retrievers, American Cocker Spaniels, German Shorthaired Pointers, Golden Retrievers and Dobermans. Along with his aunt, he has bred Labrador Retrievers and German Shorthaired Pointers under the FCI registered kennel name: "ALGERLAND". He has also owned a Weimaraner and a German Wirehaired Pointer. He has exhibited dogs and has made up, Grand Mexican, American, Grand American, International, Pan-

American, Latin-American and FCI-World championships. He has also placed his dogs as number 1 in the group (FCI group 7) in Mexico for several years. In 2003 Gerardo was granted his Judge's license from the Federación Canófila Mexicana, A.C. He has assisted Judge's seminars, handler's seminars, training seminars and grooming seminars both in Mexico and in the USA; and has been part of the Junior Handler seminar given by the Federación Canófila Mexicana, AC and speaker of different lectures in judge's seminars. Gerardo works at the Federación Canófila Mexicana, A.C. in the dog shows department, and is involved with the activities for the youngsters in the country (Seminars, junior handlers, and workshops of kids). He was appointed, by the FCI, as one of the founding members of the FCI Youth. Initiative proposed by FCI's present to encourage children, youngsters, and young adult to participate in cynological activities around the world. He is teacher at the FCM Veterinary School in the subject "Dog Show Judging" He has judged shows in different states in Mexico, and judged in the USA, in Central and South America, Asia and Australia.



**REGINA BRYANT** has been actively involved in the dog show world since childhood. She has won many junior handling competitions including National Junior Finals. In 2019, Regina was approved as an AKC judge. She has enjoyed mentoring and attending seminars for various breeds and in 2021 was invited to judge several Herding breeds at the Royal Canin Puppy Stakes in Orlando, Florida.





JOE AND JANET LOBB live in a small village about 2 1/2 hrs west of Toronto, Ontario, Canada. We have two grown children, a daughter and a son, a son-in-law and two beautiful young Grand Daughters. Now both retired, Janet enjoyed a 30 year career as a Data Base administrator for a Window and Door Manufacturer. Joe was involved in the Farm Equipment industry in Sales and Territory Management for over 45 years.

As far as Dog Show involvement, we are 'Life' members of the Canadian Kennel Club and

belong to the 'Canadian Dog Judges Association'. We were founding members of the Bluewater Kennel Club which existed for over 35 years. We are also currently members of the American Fox Terrier Club and German Shepherd Dog Club of Canada.

We have limited our breeding and showing due to our involvement in dog judging and try to attend major Dog Show Events and Specialties in the U.S.A. and Canada for education & observation purposes. We are also quite interested in All Livestock exhibitions and try to attend these events as much as possible.

Janet started judging (1996) a few years earlier than Joe and is CKC licensed for 'All Breeds' Joe continued to show dogs for others for a couple more years due to some handling commitments, before jumping into the 'Judging ring' (2002) but is now also CKC licensed to judge 'All Breeds". We started "in dogs" in 1974 with a Doberman dog of show quality. Our first litter was whelped in 1977 under the 'Dobenhaus' prefix. We were always a small kennel breeding only one litter per year. There have been many champions along the way from all litters, with many highlights. These include, Best in show, group winners, best in show puppy awards, several "awards of merit" at National specialties, best of winners at the Canadian national and "best in show" at the Doberman Pinscher club of Canada National Specialty in 1991. All of these dogs were breeder/owner handled. We also bred and owned the top producing female in Canada in 1990, with 7 champions finished that year, which in turn made us the Pedigree Pal Breeder of the year for Dobermans in Canada. (tied that year with Wrath/Liberator) In the late 1990's we were also co-breeders of Canada's Top Doberman. In 1988 we added the smooth fox terrier breed under the" FauxPaw" prefix to our kennel. We started with a Ch. Tarb the Brat granddaughter, who gave us multiple Canadian and American champions in her two litters. We have had Canada's 'top smooth' on several occasions, and dogs that were either owned or bred by us have won the Canadian National Specialty three times. A particular win of note would be AOM at the American National (Montgomery) in an entry of one hundred and sixty seven. Over the years we have had many excellent dogs of other breeds in our household and in our charge. some of which we owned and some we handled for other breeders and owners. We handled professionally, (Joe primary and Janet more as assistant and backup) for twenty-five

We handled professionally, (Joe primary and Janet more as assistant and backup) for twenty-five years. This consisted of some of Canada's top or top ranked dogs .... Handled breeds of note were Dobermans, Bernese Mtn dogs, Boxers, Australian cattle dogs, German Shepherd, Bouvier, Collies, Smooth fox terriers, Wheatens, Pugs, Chins, Setters, Springers, Goldens, Labs, Greyhounds, and two B&T Coonhounds, (both owner handled BIS winners.) We also owned, exhibited and are involved with the German Shepherd breed and handled at many Specialty events in the earlier years and now active members with the National club for GSD.

All Breed Handling highlights would include winning All Breed BIS and Specialty BIS( incl National events) with many of the above mentioned breeds. Joe piloted a Canadian bred Bernese Mtn. Dog to Best in Show at the American National Specialty as well.



**MARGARET JONES** Health Care Administrator who has been showing and training dogs since 1965, when I obtained my first Irish setter. Since then my husband and I have shared our home with Irish Setters, Cairn Terriers, Boxers and a number of different breeds including, Doberman Pinschers, a Great Dane, Afghan Hound and a Tibetan Mastiff.

As a small breeding kennel we raised and bred Irish Setters, Boxers and Cairn Terriers under the Kian Prefix and exhibited them to Group, Specialty and Best in Show wins.

We gained top Dog Awards and many Obedience titles with our Irish Setters and Boxers. Cairn terriers do not excel in the Obedience ring but they love to work at Rally, Scent detection and Earth sports.

As an All breed Judge I have been privileged to judge many times at All Breed and Specialty shows in Asia, Australia, Europe, South Africa, South America, U.K., Canada and USA.

I am a Life member of the Canadian Kennel Club and served as a Director of the Canadian Kennel Club Board from 2003-2011. During that time, I served on several Committees and Co-Chaired the CKC Charity Dog Show. I am Past President of the Canadian Dog Judges Association and Immediate Past President of the BC All Terrier Club, Cairn terrier Club Canada, and Tyee Kennel Club. I am still actively involved with local and National Breed Clubs.



**Ekarat Sangkunakup** of Thailand, began his involvement with American show dogs in 1982. Best known in the United States for his top winning Chow Chows and Dobermans. He has also had top winning Pomeranians, Shih Tzu, English Pointers, Smooth Fox Terriers, American Cockers, and Golden Retrievers.

Proudly exhibiting under the United prefix, obtaining numerous Championships across the world. United Chow Chows were the first Thai bred dogs shown

competitively in the US, and remain the premier representative of Thailand for their excellent quality, in America, and abroad.

Chow Chows bred or owned by Mr. Sangkunakup have amassed over 550 All-Breed Best in Shows, over 800 All-Breed Best Baby in Shows worldwide. In addition, over 200 Best in Shows with other breeds owned and shown over the last twenty years.

United Kennels has had more than twenty different dogs hold the #1 position both in the US and Thailand. United Chows have ranked #1 Chow Chow in the breed more than twenty times in Thailand, and extremely successful in the United States and Asia, having become the #1 Chow in various countries.

Recognized throughout the world for his in-depth knowledge of canine structure and breed type. The core of his philosophy as a breeder/judge, the preservation of the breed standards and type, ultimately depends upon the collaboration and education of dog breeders worldwide. Breeding and judging according to the standard is of the utmost importance to maintain the integrity of the breeds, and promoting continuous education for the purpose of the Preservation Breeder.

The first SouthEast Asian Judge to have judged Nationals in many countries including the United States and Canada. The first Thai Judge to have judged at the World Dog Show.

Award Challenge Certificates and CACIBS at CC/CACIB at all breed Champion Show levels by The Kennel Club Association of Thailand and FCI International Dog Shows, everywhere dogs are exhibited.

As an all breed judge, with assignments around the world including in the U.S.A , Canada , South America , Russia , Scandinavian, Europe , Australia , New Zealand , Asia as well as his native Thailand .

Actively pursuing his judging career domestically and abroad, he continues to campaign his outstanding Thai bred dogs in Thailand and the United States.



#### RHONDA SILVEIRA

I met my first Aussies in 1963 on a Goat Ranch in Southern Oregon. I bred my first litter in 1974 and started showing in 1984. In 1986 I bred our first ASCA (Australian Shepherd Club of America, Inc.) Conformation champion and registered our kennel name. I have continuously shown bred and handled my own dogs with the help of my 2 daughters who grew up in Junior Handling. In 1991 when we were AKC recognized we made the transition of the two Registries. Both of my daughters are very active in the breed and are pursuing Judging in AKC. I have Judged Aussies in ASCA as a Senior Breeder Judge since 1993. In 2016 I became an AKC Judge for Aussies and All-Breed Juniors. I am now approved for the Herding Group &

Best In Show. I continue to Add to my list of breeds in the Working and Hound Groups. I was honored to judge Best of Breed and Juniors at the 2019 USASA National Specialty at Purina Farms.



#### RAY STRUDWICK

Burpham Retrievers UK

Our life in dogs started back in 1976 when I purchased a Golden Retriever bitch as a birthday present for my wife Lyn. Three years later our first litter arrived which introduced us to the show world where we bred and showed many Goldens with great success.

Our first Flatcoated Retriever arrived in 2003 from Maureen Scott's Branchalwood kennel giving us the opportunity in the last 20 years to breed and show, making up four male Show Champions, Branchalwood Aylanmhor for Burpham, Branchalwood Belmenach for Burpham, Downstream Fair & Square for Burpham and Burpham Million Love Songs who is still in the show ring along with his young granddaughter Burpham Lotties First Love.

I both judge Golden Retrievers and Flatcoated Retrievers at Championship level. I also judge 7 other Gundog breeds plus the Gundog Group & Retriever Group at Championship shows, including Nova Scotia Duck Tollers, Curly Coated Retrievers, English Cocker Spaniels, Weimeraners, and English & Irish Setters. I have had the honour of judging in many overseas countries including Australia, New Zealand.



**DR. DONALD STURZ** began participating in the sport of dogs as a child. He was ranked as the number one Junior Handler in the U.S. for three consecutive years. Dr. Sturz has bred, owned, and handled All-Breed and Specialty Best in Show winners and nationally ranked dogs in a variety of breeds, most notably Golden Retrievers, Miniature Poodles, and Pembroke Welsh Corgis. He currently owns a French Bulldog and a Bull Terrier.

Dr. Sturz has adjudicated at major all-breed and specialty shows worldwide, including ten times at the Westminster Kennel Club show and Best in Show at Westminster in 2022. In 2020, he was voted Judge of

the Year at the Purina Pro Plan® Show Dogs of the Year award ceremony.

He currently serves as the President of the Westminster Kennel Club and is Vice-President of the Poodle Club of America. He is a member of the Westchester Kennel Club and the Bull Terrier Club of America. He was honored with ROM judging status by the Bull Terrier Club of America.

#### **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada. (Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler MUST be the owner/co- owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE BREED JUDGING on that day. TCN Fees WILL NOT be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class MAY NOT COMPETE in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

#### **NON-REGULAR CLASSES**

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

#### BREEDER/OWNER/HANDLER COMPETITION (BOH - Sunday)

Unofficial/Exhibitor Eligibility

- 1. Exhibitors must declare their dog eligible for Breeder/Owner/Handler Competition at the time of entry using the check box on the entry form (either paper or electronic). If the handler changes from the time of entry to exhibition, the exhibitor is responsible for advising the ring steward if the entrant is no longer eligible.
- 2. The handler must be a breeder/owner of record listed in the catalogue.
- 3. Dogs must be handled by a listed breeder & handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
- 4. The BOH in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

#### Determining Best BOH in Breed

The selection of the Best BOH in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best BOH in Breed. Judging of the breed for the regular show may determine the dog that is awarded the Best BOH in Breed.

#### Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best BOH in Breed it will also be awarded Best BOH in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best BOH in Group.
- If the regular show Best of Breed winner is not eligible for Best BOH in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best BOH in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best BOH in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best BOH in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best BOH in Breed, excuse all eligible champions and then choose Best BOH in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Best BOH in Breed.

If no dog remaining in the ring is eligible for the Best BOH in Breed competition, no award will be made and there will not be representation in group competition for the Best BOH in Group. Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible breeder.
- Group judging for the Best BOH in Group may take place in separate rings from regular group judging.
- Judging for the Best BOH in Show is after regular Best in Show judging.

#### **GENERAL RULES GOVERNING THESE SHOWS**

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from:

CKC online at www.ckc.ca

- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
- 2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
- 6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
- 7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
- 8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
- 9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
- 10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
- 11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
- 12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
- 13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within14 days of the action.

#### CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

- 15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.
- (b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.
- (c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.
- 15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.
- (b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.
- 15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.
- (a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.
- (b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.
- 15.3 Grand Champion Excellent (GChEx) (48-06-12)
- 15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.
- 15.3.2 To earn the title a dog must have earned the following during their career as a Special:
- (a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)
- (b) three (3) Group 1st, or three (3) breed specialty best of breed wins.
- (c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.
- 15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.
- 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.
- 2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
