**Closing date - 6:00 PM, Wednesday September 4, 2019.** Entries must be delivered to the Test Secretary by the closing date. The club cannot accept entries delivered after this date and time.

Entries must be mailed or sent by courier to the postal address of the test secretary. Faxed, e-mailed, or hand delivered entries are not acceptable. Each entry must be mailed in a separate envelope. All entries must be made on an official CKC entry form. Owners are responsible for errors in making out entry forms, regardless of who completes the entry form. Incomplete or improper entry forms will not be accepted. To prevent delays, entrants using couriers are encouraged to mark their envelope with the instructions "no signature required". After the closing date, the club will send out acceptance letters or emails, advising entrants of the status of their entry. A map showing directions to the rendezvous site will be provided, if necessary.

**Prizes:** Passing dogs will receive a rosette.

**Entry fee:** UTD \$90.00

Fees are payable to: Lady Slipper Kennel Club. Post-dated cheques will not be accepted. NSF Cheques will be considered non-payment of entry fees. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation are appreciated.

**Listing fee:** \$11.50 “A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.”

**Withdrawals and Entry Fee Refunds** - If an entry withdraws before the closing date, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

**Bitches in Season** - Bitches in season will be allowed to participate but must run last and must be kept separated from all other dogs during the event.

**\*\*NEW\*\*** An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members. LSKC will use all reasonable care to ensure the safety of dogs and persons at the test. However neither LSKC nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

*CKC Tracking Rules (13.7): It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.*
